


LTFV Forms JV in Honolulu

The synergistic combination of LTFV's access to resources and NORPAC's access to high-end seafood consumers will add value and strength to both companies. As one of the largest fishing and seafood companies in the Asia-Pacific region, LTFV has continuously embarked on organizational and operational improvement programs geared towards providing more value-added products and services.

One of the recent milestones in our operational history is the finalization of our joint venture agreement with Norpac Fisheries Export, a key producer and distributor of seafood products for Hawaii and mainland US markets.

Our partnership with Norpac has diversified our fresh tuna product lines to include frozen seafood products. The acquisition also allowed us to gain a strong foothold in the lucrative food services and retail markets.

For product development expansion, LTFV is establishing a processing base in China. This will facilitate an efficient distribution model of innovative products from China to overseas markets like the US, Japan and EU.

LTFV will also establish a fuel hub in the Western Pacific to address cost management for our fishing fleet operation and maximize the fishing bases' services and fuel products being provided to other vessels and even airlines in the Western Pacific.

On distribution and logistics, our affiliate Asia Pacific Airlines (APA), successfully bought its 3rd aircraft. APA now fully owns 3 B727-200 aircraft and leases other planes. The move is in line with cost management initiatives as well as with the objective of controlling and sustaining the highest standards of air freight operations.

Organizationally, LTFV continues to align itself to a structure that will enable the execution of the companies' strategies. To streamline the supply chain activities and consolidate the operations processes, our long-time executive and one of LTFV's pioneers Samuel Chou was appointed Chief Operating Officer (COO).

Lastly but most importantly, I am excited to bring to you through this issue the summary of our commitment to environmental sustainability and conservation. LTFV continues to explore ways to elevate our business activities to world class standards and environmentally sound practices.

LTFV Develops China Business

联泰渔业开展国内业务

One of the expansion strategies of Luen Thai Fishing Venture, Ltd. (LTFV) this year is to establish processing operations and a marketing office in China. The company is shopping around for factories to partner with and intends to put up a subsidiary to take charge of business development in China.

The subsidiary will serve as an umbrella company that will oversee product development, inventory control, trading, sourcing, processing and manufacturing, imports and exports, sales and marketing, and domestic market distribution, among others.

The LTFV-China subsidiary will serve as an umbrella company that will oversee product development, inventory control, trading, sourcing, processing and manufacturing, imports and exports, sales and marketing, and domestic market distribution for the whole China market.

For the Chinese market, the company will develop three kinds of products: Store Ready Packaging, Heat and Serve Seafood, and Ready-to-Cook Products.

These products cater to the needs of consumers and commercial (e.g. Japanese restaurant chains) and institutional buyers (e.g. the military).

今年联泰渔业的一项扩张战略是要在国内设立加工运作点并建立销售办事处。公司现在正在物色有资质的合作工厂,并计划设立一个子公司来开拓中国业务。该子公司将统筹有关事宜,负责产品开发、库存管理、贸易、采购、加工制造、进出口、市场营销及国内市场的分销等。

联泰渔业子公司将监管产品开发、库存管理、贸易、采购、加工和生产、进口和出口、市场营销以及为整个中国市场进行市场配送。

在中国市场,公司将开发以下三个产品系列:熟食产品、加热即食品、加工半成品。这些产品能很好地迎合广大消费者,商业采购(如日式连锁餐厅)和军队等机构购买者的需求。

公司还打算从美国的兄弟公司购买白肉鱼类原料(如:鳕鱼、鲈鱼、比目鱼等)将其转售给中国的加工厂及分销商。



The company also plans to source white meat fish raw materials (e.g. pollock, yellowfin sole, halibut, blue whiting, cod, flounder) from its sister company in the US and sell these to processors and distributors in China.

LTFV to Develop Western Pacific Fuel Hub 联泰渔业将在西太平洋建燃料中心

4 New Vessels Joined LTFV Fleet



Luen Thai Fishing Venture, Ltd. added 4 new long-line fishing vessels to its fleet last July. Another set of 4, 450-horsepower vessels are being built in Zi Shun and Xi Ming shipyards in Longhai, China and are expected to be completed by end of October.

The eight new vessels sail under the flag of the Republic of Marshall Islands.

Shipyard Projects to Cut Repair Costs, Raise Revenues

修船厂计划降低维修成本，增加收入



Luen Thai Fishing Venture, Ltd. (LTFV) plans to set up repair centers in China and Kosrae, an island state in Micronesia, to bring down the cost of maintaining its fishing vessels. Initially, two vessels have been sent to China for major repairs. If all goes smoothly, all other repair jobs will be sent to the chosen shipyard by the end of the year. In the meantime, LTFV intends to service not only its fleet at Kosrae, which is strategically located in the middle of the Western Pacific region, but eventually non-LTFV small or large size vessels as well.

LTFV, SZLC Promote Premium Tuna at Qingdao Food Expo

联泰渔业、深圳联成联手 在青岛渔业博览会促销优质金枪鱼



LianCheng Overseas Fishery (Shenzhen) Co., Ltd., Luen Thai Fishing Venture's strategic partner in China, showcased the group's premium grade fresh sashimi tuna at the Qingdao trade exhibit last year. LianCheng (SZLC) is currently the top supplier of fresh tuna and other fish products to the United States and Japan .

The China Fisheries and Seafood Expo is Asia's largest seafood and aquaculture exposition. The 11th staging of the event was held from November 1 to 3 last year at the Qingdao International Exhibition & Convention Center. It attracted exhibitors from 33 countries and about 15,000 visitors from 40 countries.

Willie Tan, CEO of Luen Thai Private Group, and Samuel Chou, president of LTFV Far East, attended the Qingdao exhibit. Hexie Li, vice president and general manager, led the SZLC delegation.

APA Buys 3rd Aircraft

亚太航空公司购买第三架飞机

APA has recently purchased its third aircraft. The purchase was a financial decision with many benefits to the company.

With its current fleet of three (3) long range B727-200, APA will continue to provide logistical support to the Luen Thai Fishing Ventures, and haul mail on behalf of the United States Postal Service.

The purchase of the 3rd aircraft results in lower operating costs versus leasing the plane. The 3rd plane also allowed APA to expand its charter service by basing a plane in Honolulu and providing additional flights to Christmas Island, American Samoa and also most recently allowing APA to extend onwards from American Samoa to Niue, which is a former colony of New Zealand.

Another benefit that can be derived from this purchase is to generate maximum revenue, which requires at least two (2) planes to be in service.

APA is managed by a team with extensive aviation experience totally over 100 combined years.

拥有三架长程B727-200型货机的亚太航空公司，将继续为联泰渔业提供物流运输服务并且为美国邮政服务公司提供邮寄服务。

相对于继续租用运输机而言，此次购买实质上降低了运作成本。这架运输机的购置同时也使得公司扩大了其包机业务的规模，可以使用一架飞机驻扎在火奴鲁鲁，为圣诞岛萨摩亚群岛及纽埃岛提供航空运输服务。

亚太航空公司的团队拥有累积超过100年的航空运输经验。

LTFV Joins Dalian Expo in November 2007

联泰渔业将于2007年11月 参加大连渔业博览会

联泰渔业有限公司将参加2007年中国国际渔业博览会。这个亚洲最大的海产品博览会，将于11月6日在大连国际会展中心开幕，为期三天。其间2007中国水产养殖展和2007中国水产科技展将同时在大连举行。

中国市场对联泰渔业至关重要，产品投放国内市场的同时，也大量地出口到美国、日本等海外市场。2008年公司在中国的业务将会扩大到冷冻金枪鱼及冷冻海产品。

2005年中国海鲜品的进口额上升了28%，达到40亿美元，这有力地证明了中国海鲜品市场的巨大潜力。同年，中国海鲜加工品的出口额高创79亿美元，这使中国成为世界上最大出口国。

Luen Thai Fishing Venture, Ltd. (LTFV) will be at the China Fisheries & Seafood 2007 in November. Asia's largest seafood show, a three-day event, opens at the Dalian World Expo Center on November 6. Two related trade fairs will be held in Dalian at the same time, the Aquaculture China 2007 and Seafood Technology China 2007.



LTFV has a major stake in China where it sells seafood to the domestic market and exports to overseas markets such as Japan and the United States. The company is expanding its business in the country with the launch of its frozen tuna and seafood business in 2008.

China has a big appetite for seafood with imports climbing 28 percent to US\$4 billion in 2005. Its seafood processors, however, are exporting more products with dollars sales reaching US\$7.9 billion for the same year, making China the world's leading exporter.

Luen Thai Fishing Ventures (LTFV) is a wholly owned subsidiary of Luen Thai International Group, a Hong Kong based corporation.

LTFV began operations in 1994 in Pohnpei, Federated States of Micronesia, and now owns more than 70 long-line vessels. LTFV aims to be recognized by customers as the leading global supply chain service provider of quality fresh tuna and seafood products.

With the steady growth of the fisheries industry in the Western Pacific, LTFV has intensified its focus on the environment, especially on developing and implementing environmentally friendly fishing practices. By constantly improving measures within the company and fostering relationships in the community, LTFV strives to attain the goals of sustainability and conservation. The long-line fishing method in itself supports sustainability and is by-catch friendly.

Internally, LTFV invests in and utilizes only the most up-to-date fishing equipment. Employees and crew are trained to use the equipment properly and are educated about the compliance regulations. Externally, LTFV cooperates with local governments and industry associations to actively support conservation and sustainability initiatives and regulations.

Conservation



LTFV recognizes the importance of maintaining the earth's ecosystem and minimizing the harm of fishing practices. Thus, LTFV has installed and utilizes the following environmentally friendly equipment:




Super Spool System (SSS)

Installed in all 70 of our vessels, the SSS was certified "friendly" for long-line fishing by the WPRFMC and is an advancement in environmentally responsible fish gear.



Circle hooks

The fleet has transitioned to using circle hooks, which have been proven to dramatically reduce the interaction between fishing gear and sea turtles.



Bird Scaring Line

We have successfully deployed Bird Scare Lines on our vessels fishing in the Marshall Islands. Observers noted a 100% reduction in bird interactions when deployed. This highlights the efficacy of this technology and our dedication to good marine stewardship.



Monofilament Line

Reduces the by-catch of sharks. According to on board fishing observers from Shanghai Fisheries University, no sea turtles were caught, and when sea birds were seen, there was no interaction with the fishing gear, in the past three voyages of LTFV scheduled last Oct. 27 – Nov. 5, 2006, Dec. 4-19, 2006, and Jan. 24 – Feb. 5, 2007.

Sustainability

LTFV believes that cooperating with local governments and fishing agencies is essential in sustaining the fishing industry. For example, LTFV maintains integrity in catch-reporting. LTFV owns the majority of its vessels and is thus able to keep accurate records of their catch. LTFV works closely with each country's fishing authority in reporting the catch and by-catch of all vessels.



Western Pacific

LTFV remains committed to cooperating with the Western Pacific Regional Fishery Management Council (WPRFMC) on the conservation of the marine environment and the management of fisheries in the Western Pacific through its application of responsible fishing practices in its fishing operations.

In February 2007, LTFV joined the Asia and Pacific By-catch Consortium in Hawaii as one of the Steering Committee members of the WPRFMC. The Consortium aims to resolve issues involving long-line by-catch of sea turtle, sea birds, and small sharks. LTFV strongly advocates measures to protect the species not targeted by fisheries.

Philippines

LTFV is also in agreement with the Philippine Fishery Department and WWF to run a trial operation in the Philippine waters to use circle hooks to lessen sea-turtle by-catch.

China

LTFV works with Shanghai Fisheries University to develop bird-scaring lines to avoid accidental catching of sea birds.

可持续发展与环境保护

联泰渔业是总部位于香港的联泰国际集团的全资子公司，公司于1994年在密克罗尼西亚联邦的波纳佩州开始营运，目前已经拥有超过70艘延绳钓船。联泰渔业旨在成为客户公认的全球领先的最佳新鲜金枪鱼及海产品供应链服务提供商。

随着公司在西太平洋地区业务的稳定成长，联泰渔业越发重视环境问题，而且开发并应用了环保的捕捞方式。通过不断改善公司内部措施和促进社区关系，联泰渔业力求达到渔业的可持续发展和资源的保护。延绳钓捕鱼的方法本身就是用一种可持续发展并可降低其他生物捕获率的作业方式。

对内，联泰渔业公司投资并采用最先进的捕鱼设备。船员和员工在对这些设备的使用和捕鱼规则的遵守上都训练有素；对外，联泰渔业与当地政府和行业协会合作，积极支持对资源保护和渔业可持续性发展努力与规定。

保护



联泰渔业认识到保护地球生态系统，将捕鱼活动可能对其造成的损害最小化的重要性，所以公司安装并使用了下列有利于环境保护的设备：



大滚筒

在公司的70艘渔船上都安装了大滚筒。这种设备被西太平洋管理委员会鉴定为延绳钓作业中的“友好伙伴”它的使用在环境保护方面也是一项极大的进步。



圆钩

船队在捕鱼时转而使用该设备，迄今已经证明该设备能极大地降低对海龟的渔获。

联泰渔业相信与当地政府及渔业机构的合作对渔业的可持续发展是十分重要的。举例来说，联泰渔业一直完整地保留渔捞报告。由于大部分渔船由联泰渔业自己拥有，这就使得我们有能力确保渔捞记录的准确性。联泰渔业与各国渔业主管当局紧密合作，准确及时地向其报告所有渔船的渔获情况。



西太平洋

联泰渔业长期与西太平洋地区渔业管理委员会合作，采用负责任捕鱼方式，保护西太平洋地区的海洋环境和渔业管理。

2007年2月，联泰渔业作为西太平洋地区渔业管理委员会工作委员会成员，加入了设在夏威夷的亚太兼捕协会，该协会旨在解决延绳钓捕鱼过程中对海龟、海鸟及小鲨鱼的误捕问题。联泰渔业强烈倡议采取各种措施，以保护这些品种不会被捕获。

菲律宾

联泰渔业还同菲律宾渔业部及世界野生动物保护基金签定协议，在捕鱼中试用环型钩，以降低对海龟的渔获机率。

中国

联泰渔业同上海水产大学合作，研发了多种惊鸟线，以避免海鸟遭到误捕。



惊鸟缆线

我们已经成功研发并在马歇尔岛的捕鱼中使用了该设备，据观察，该配置能100%地消除对海鸟的渔捕。这更显现了该配置的功效及联泰渔业对海洋生物保护的贡献。

单纤维线

降低对鲨鱼的渔获。根据来自上海水产大学的调查员三次出海的观察，没有海龟被误捕的记录，海鸟也会对渔具退避三舍。这三次出海的时间分别是：2006.10.27-11.05；2006.12.04-12.19；2007.01.24-02.05。






